## Request for Qualifications/Proposals Professional Engineering Services

The NCRPC requests qualification statements from engineering firms interested in preparing PERs for infrastructure projects for disadvantaged communities in the NCRPC region. A firm may be selected by one or all communities participating, but may be limited to working with three communities due to time constraints. The NCRPC is currently taking applications from towns for this service and engineering firms are encouraged to have towns with a need for this service to reach out to Deb Ohlde.

The projects may involve a phased approach depending on size and selection for the PER service does not guarantee selection for design and construction services. The qualification statement should include:

- a.) The specialized experience and technical competence of the firm with respect to water, sewer, and/or street infrastructure improvement projects. You may note that you wish to be considered for one type of project only.
- b.) The capacity and capability of the firm to perform the work in a reasonable time. PERs must be completed by May 1, 2025.
- c.) The past record of performance of the firm with respect to such factors as quality of work, control of costs, and ability to meet schedules. References will be checked.
- d.) The firm's proximity to and familiarity with the area where the project is located. This includes the firm's past work with the community.
- e.) References from previous clients of related work with the firm within the past three years.

Ability to complete the work on a designated date as necessary, plus c) above, shall receive primary consideration. Please see the scoring matrix attached.
